

## EDUCATIONAL IMPACT STATEMENT

### The Proposed Gradual Grade Truncation of P.S. 333 Manhattan School for Children (03M333) from a K-8 School to a K-5 School in Building M118 Beginning in the 2026-2027 School Year

#### I. Summary of Proposal

The New York City Department of Education (NYCDOE) is proposing to gradually truncate grades 6-8 of P.S. 333 Manhattan School for Children (03M333), referred to as MSC, in building M118 beginning in the 2026-2027 school year. A gradual grade truncation means that the school will serve fewer grades than it currently offers over a period of time. MSC is a district school serving students in grades K-8 in M118. MSC is co-located with two existing district middle schools currently serving students in grades 6-8: Community Action School – M.S. 258 (03M258), referred to as CAS, and Lafayette Academy (03M256). M118 is located at 154 West 93 Street, New York, NY, 10025, in Community School District 3, referred to as District 3. M118 also houses the District 3 Superintendent’s office, the Community Education Council (CEC) 3 office, and the Community Based Organizations (CBOs) Beacon and Association to Benefit Children (ABC).<sup>i,ii</sup>

A co-location means that two or more school organizations are located in the same building and may share common spaces, such as:

- Auditoriums;
- Gymnasiums;
- Libraries; and
- Cafeterias.

This proposal is grounded in the NYCDOE’s responsibility to strengthen elementary programming at MSC while expanding access to high-quality middle school options across District 3. The NYCDOE believes that every student in District 3 and across the city deserves a high-quality and academically rigorous education — one where they are supported to learn and grow. Since the 2024-2025 school year, the District 3 Superintendent’s team has been convening working group meetings across the district to discuss how we can ensure all of our students have access to these kinds of schools and experiences. The working groups explored ways to support enrollment and school performance and address space challenges at several schools. The working group members include principals, Parent Teacher Association (PTA) presidents, school and district United Federation of Teachers (UFT) representatives, and CEC 3 representatives. This proposal was developed through these working group conversations as a solution to address the school’s enrollment challenges in its middle school grades by focusing on a smaller grade span and working to build a quality elementary school option. A gradual truncation, in which the school stops enrolling students in the entry grade and closes its middle school gradually, also allows current students to remain enrolled at their school as they complete their middle school education.

The NYCDOE is proposing to truncate grades 6-8 of MSC to allow the school to focus on a smaller grade span and continue to build a quality elementary school option. MSC's middle school grades have been experiencing low and declining enrollment. Since the 2020-2021 school year, MSC has experienced a 17% decline in middle school enrollment and has served fewer than 160 students in grades 6-8.<sup>iii</sup> This has created budgetary challenges that have limited the opportunities the school has been able to provide its middle school students. For example, low enrollment in MSC's middle school has meant that its middle school students receive two fewer English Language Arts and math classes per week compared to citywide averages.

Additionally, while the K-8 school model can provide an opportunity for students to benefit from a stable community for a longer period of time, that hasn't been the reality at MSC where most families don't choose to attend the school for both elementary and middle school. From the 2021-2022 school year to the current school year, only between 9 and 14 students have articulated from grade 5 to grade 6 at MSC. If this proposal is approved, this truncation will enable MSC to focus exclusively on serving students in grades K-5 and continue to build a quality elementary school option.

If this proposal is approved by the Panel for Educational Policy (PEP), beginning in the 2026-2027 school year, MSC will gradually phase out one middle school grade per year until it ultimately serves students in grades K-5 and will be able to focus exclusively on its elementary school grades and further its ability to serve as a quality sustainable elementary school option in District 3. If this proposal is approved, MSC will no longer enroll students in grade 6 after the 2025-2026 school year. In the 2026-2027 school year, MSC will only serve students in grades K-5 and 7-8. In the 2027-2028 school year, MSC will serve students in grades K-5 and 8. After the conclusion of the 2027-2028 school year, MSC will only serve students in grades K-5.

If this proposal is approved, the gradual truncation of MSC's middle school will provide current students in grades 6 and 7, as well as any students in grade 8 who do not meet promotional criteria, with the option to continue their education at MSC alongside their peers through the end of middle school. If this proposal is approved, all current MSC middle school students will continue to be supported in meeting promotional requirements as they continue their education at MSC through eighth grade. If a student does not meet promotional requirements in a grade that will no longer be served by MSC the following year, the District 3 Family Support Coordinator, in collaboration with MSC school staff, will help identify another middle school option for the duration of their middle school experience. Students who receive an offer to MSC for grade 6 will receive individualized support from the NYCDOE's Office of Student Enrollment (OSE) and the District 3 Superintendent's team to assist with securing seats in other middle schools. Any student who wishes to attend middle school in M118 will have the ability to enroll in Lafayette Academy or CAS if they desire.

## II. Proposed or Potential Use of M118

M118 has the capacity to serve approximately 900 students according to the 2024-2025 Enrollment, Capacity and Utilization Report, also known as the Blue Book.<sup>iv</sup> Building capacity and utilization figures in this EIS are based on the standard methodology for calculating such figures, using target capacity, as described in Appendix B of this EIS.

If this proposal is approved, beginning in the 2026-2027 school year, MSC will no longer admit students in grade 6 and will only serve students in grades K-5 and 7-8 in M118. In the 2026-2027 school year,

M118 is projected to have a total building enrollment of approximately 735-875 students across MSC, CAS, and Lafayette Academy.<sup>v</sup> Enrollment projections for M118 for the 2026-2027 school year are as follows:

- MSC is projected to serve approximately 330-410 students;
- CAS is projected to serve approximately 150-180 students; and
- Lafayette Academy is projected to serve approximately 255-285 students.

As such, in the 2026-2027 school year, M118 will have a projected building utilization rate of approximately 82-97%.

If this proposal is approved, in the 2028-2029 school year, MSC will cease to serve students in grades 6-8 and will only serve students in grades K-5. In the 2028-2029 school year, M118 is projected to have a total building enrollment of approximately 745-865 students across MSC, CAS, and Lafayette Academy. Enrollment projections for M118 for the 2028-2029 school year are as follows:

- MSC is projected to serve approximately 265-325 students;
- CAS is projected to serve approximately 165-195 students; and
- Lafayette Academy is projected to serve approximately 315-345 students.

As such, in the 2028-2029 school year, M118 will have a projected building utilization rate of approximately 83-96%.

Table 1 below describes the current and proposed grade spans in M118 over a four-year period if this proposal is approved.

If this proposal is approved, there will be sufficient instructional and administrative space in M118 to accommodate MSC, Lafayette Academy, and CAS pursuant to the Citywide Instructional Footprint (the Footprint). ### III. Impact of the Proposal on Students, Schools, and Community

#### A. Impact on Students

If this proposal is approved, beginning in the 2026-2027 school year, MSC will gradually phase out one middle school grade per year until it eventually serves students in grades K-5 and will be able to focus exclusively on its elementary school grades and further its ability to build a quality elementary school option for District 3 students. If this proposal is approved, MSC will no longer enroll students in grade 6 after the 2025-2026 school year. In the 2026-2027 school year, MSC will only serve students in grades K-5 and 7-8. In the 2027-2028 school year, MSC will serve students in grades K-5 and 8. After the conclusion of the 2027-2028 school year, MSC will only serve students in grades K-5.

If this proposal is approved, the gradual truncation of MSC’s middle school will provide current students in grades 6 and 7, as well as any students in grade 8 who do not meet promotional criteria, with the option to continue their education at MSC alongside their peers through the end of middle school. If this proposal is approved, all current MSC middle school students will continue to be supported in meeting promotional requirements as they continue their education at MSC through eighth grade. If a student does not meet promotional requirements in a grade that will no longer be served by MSC the following year,

the District 3 Family Support Coordinator, in collaboration with MSC school staff, will help identify another middle school option for the duration of their middle school experience. Students who receive an offer to MSC for grade 6 will receive individualized support from OSE and the District 3 Superintendent's team to assist with securing seats in other middle schools. Any student who wishes to attend middle school in M118 will have the ability to enroll in Lafayette Academy or CAS if they desire. Please see Appendix A of this EIS for a list of schools serving grades 6-8 in District 3.

District 3 district schools currently have the capacity to serve approximately 4,450 students in grades 6-8 while only 3,369 such students are currently enrolled in District 3 district schools in the 2025-2026 school year, which means that District 3 currently has an excess of approximately 1,100 grades 6-8 seats in district schools. In an additional separate EIS, the NYCDOE is concurrently proposing to truncate grades 6-8 of The Riverside School for Makers and Artists (03M191), referred to as RSMA, in building M342 in the 2026-2027. That proposal was generated through engagement with the mid-district and southern district working groups as a way to support enrollment and performance at RSMA. If the proposal to truncate grades 6-8 of RSMA and this proposal are both approved, they will collectively result in the removal of two middle school options in District 3. If both concurrent proposals are approved, District 3 schools will have the capacity to serve approximately 4,100 students in grades 6-8 and will still have an excess of approximately 750 grades 6-8 seats. There are also approximately 689 students in grades 6-8 being served in four charter schools in District 3, which students in District 3 can also apply to. Therefore, there is a sufficient number of seats within District 3 to accommodate the current students in grades 6-8 of MSC and RSMA.<sup>vi</sup>

The proposed truncation of the middle school grades at MSC will allow the school to focus exclusively on its elementary school grades and further its ability to build a quality elementary school option for District 3 students.

## 1. IMPACT ON CURRENT AND FUTURE STUDENTS ATTENDING MSC

### *ACADEMIC OFFERINGS:*

If this proposal is approved, beginning in the 2026-2027 school year, MSC will gradually phase out one middle school grade per year until it ultimately serves students in grades K-5 and will no longer offer middle school programming. MSC will continue offering all classes to support all current students as they work to meet mandated articulation requirements through the remainder of the 2025-2026 school year. MSC will cease to offer academic programming for grades and programs being phased out beginning in the 2026-2027 school year. After the conclusion of the 2027-2028 school year, MSC will only serve students in grades K-5. As such, this proposal is not expected to impact academic programming for students served in elementary school.

MSC is a member of the Progressive Redesign Opportunity Schools for Excellence (PROSE) program. PROSE is a joint program between the UFT, the Council of School Supervisors and Administrators (CSA), and the NYCDOE that focuses on growing effective school leadership, collaboration, and trust to implement innovative practices outside of existing rules.<sup>viii</sup> PROSE offers the ability for schools to alter some of the basic parameters by which the school functions and leverages flexibilities from UFT and CSA contracts, as well as from Chancellor's Regulations, to increase student achievement. If this proposal is approved, MSC's participation in the PROSE program would remain unchanged.

As MSC is designated as a PROSE school, MSC utilizes a foundational model which provides the following academic program opportunities:

- NY Inspires and High School Readiness;
- Progressive Education;
- Sibling continuity and family stability; and
- State of the art greenhouse.

MSC currently serves students with and without disabilities. Students with Individualized Education Plans (IEPs) receive special education programs and services, as recommended on their IEPs. These programs and services may be provided in general education and/or special education classrooms, as well as separate settings depending on need.

MSC is currently educating students recommended for the following programs and services:

- Integrated Co-Teaching (ICT);
- Special Class (SC);
- Special Education Teacher Support Services (SETTS); and
- Other related services.

If this proposal is approved, students with disabilities will continue to receive services in accordance with their IEPs. Services are tailored to meet the individual needs of the students with disabilities currently enrolled and, as such, may vary from year to year. Any fifth-grade student continuing to middle school who requires a barrier-free school will have the opportunity to remain in the building upon enrolling at Lafayette Academy or CAS.

Additionally, MSC provides English as a New Language services to currently enrolled English Language Learner (ELL) students. If this proposal is approved, these services will continue to be provided, and all students will continue to receive their mandated services.

#### *EXTRA-CURRICULAR ACTIVITIES AND PROGRAMS, SPORTS AND PARTNERSHIPS:*

This proposal is not expected to impact any particular extra-curricular activities, special programs, sports or partnerships currently offered at MSC for the remainder of the 2025-2026 school year.

If this proposal is approved, MSC will begin to phase out middle school grades in the 2026-2027 school year. Extra-curricular activities will still be offered to the remaining students; however, it is anticipated that MSC will offer fewer extra-curricular activities, sports, and partnerships for middle school students over the course of the phase out as the school will have fewer grade offerings, students, staff, and resources. The specific programs offered at a given school are always subject to change. This is true for all City schools, which annually modify extra-curricular offerings based on student demand and available resources. Elementary extra-curricular activities, sports, and partnerships will not be impacted as a result of this proposal, if approved.

MSC currently offers the following:<sup>viii</sup>

#### *ADMISSIONS:<sup>ix</sup>*

At the middle school level, MSC currently admits students through the middle school admissions process with a priority given to current fifth grade students enrolled in the school, followed by applicants with siblings who will be enrolled in the school the following school year, then residents of the elementary school zone, then District 3 students and residents. MSC's middle school grades are open to District 3 students and residents, then students and residents of New York City. As part of the District 3 Diversity in Admission (DIA) initiative for middle schools, MSC also has DIA priorities.<sup>x</sup> Under the District 3 DIA initiative, there is a priority to applicants eligible for Free or Reduced-price Lunch (FRL) for 25% of seats. The remaining 75% of seats are open to all students.

If this proposal is approved, in the 2026-2027 school year, MSC will no longer admit or serve students in grade 6 and will only serve students grades K-5 and 7-8. In the 2027-2028 school year, MSC will serve students in grades K-5 and 8, and in the 2028-2029 school year and beyond, the school will only serve students in grades K-5.

As such, for the 2026-2027 school year and beyond, MSC will no longer be an option for families in the middle school admissions process beginning in the 2026-2027 school year, when the school will no longer admit 6<sup>th</sup> grade students. Any students who receive an offer for the 2026-2027 school year will be supported in securing a seat at another middle school that meets their needs. Students enrolled in 5<sup>th</sup> grade at MSC in the 2025-2026 and 2026-2027 school years will no longer have priority to enroll in 6<sup>th</sup> grade at MSC and will instead enroll in other middle schools of their choice through the middle school admissions process.

District 3 students will continue to have access to a broad range of schools serving middle school grades. Please see Appendix A of this EIS for a list of schools serving grades 6-8 in District 3.

This proposal is not expected to impact elementary school admissions at MSC. MSC is a non-zoned elementary school that admits students through the kindergarten admissions process and gives priority to students who live in District 3.

## 2. IMPACT ON CURRENT AND FUTURE STUDENTS ATTENDING CAS

This proposal is not expected to impact current or future student enrollment, admissions, or programming at CAS.

Additionally, CAS is a Community School. Community Schools are intended to be neighborhood hubs that provide additional support for families from community partners. As a Community School, CAS provides wrap-around services, such as mental health services and after-school programs through CBO partnerships. This proposal, if approved, will have no impact on CAS's status as a Community School.

### *ACADEMIC OFFERINGS:*

This proposal is not expected to impact current or future academic offerings at CAS.

As part of the District 3 DIA initiative for middle schools, CAS also has a DIA priority. Under the District 3 DIA initiative, there is a priority to applicants eligible for FRL for 25% of seats. The remaining 75% of seats are open to all students.

Additionally, CAS also admits students through an ACES program, a special education program intended to support students with intellectual disabilities or multiple disabilities who participate in New York State Alternate Assessment. ## 3. IMPACT ON FUTURE MIDDLE SCHOOL STUDENTS IN DISTRICT 3 AND THE CITY

If this proposal is approved, students in District 3 and the City will no longer have an opportunity to enroll in MSC for middle school as the school will no longer enroll new students in grade 6 following the conclusion of the 2025-2026 school year and will no longer admit students through the middle school admissions process.

This proposal is not expected to otherwise impact the admissions processes at other District 3 middle schools. If this proposal is approved, students will continue to have access to a broad range of middle school options. Through the middle school admissions process, students are offered the opportunity to apply to a range of middle schools within their district, and/or schools with borough-wide or citywide eligibility. As noted above, there is a sufficient number of middle school seats in District 3 to accommodate any future middle school students who would be served at MSC or RSMA, should the middle school grades of MSC and RSMA be truncated. Please see Appendix A of this EIS for a general list of schools serving grades 6-8 in District 3.

##### 1. Overview of Space in M118

According to a building walkthrough and survey of M118 conducted on February 11, 2026, by a representative from the NYCDOE's Office of Space Management (OSM), M118 has a total of:

- 57 full-size rooms (FS),<sup>xiv</sup>
- 16 half-size rooms (HS),<sup>xv</sup>
- 13 quarter-size rooms (QS),<sup>xvi</sup> and
- 1.0 full-size equivalent rooms (FSE) of designed administrative space.

The spaces listed below are shared spaces or contain building services and will not be included in the allocation of instructional or administrative space for an individual school:

- The CBO ABC occupies 1 QS;
- The CBO Beacon occupies 1 QS;
- The CEC 3 Office occupies 1 QS;
- The custodian's office occupies 1 QS;
- The nurse's office occupies 1 QS;
- The School Based Support Team occupies 1 QS;
- The District 3 Superintendent's office occupies 1 FS and 3 HS; and
- The School Safety office occupies 1 HS.

M118 also has the following common spaces, which will not be included in the allocation of instructional or administrative space for an individual school:

- An auditorium;
- A cafeteria; and
- Two gymnasiums.

Excluding the spaces outlined above, M118 has the following rooms available to be allocated:

  - MSC's administrative space allocation of 4.0 FSE will be comprised of 2 FS, 1 HS, 2 QS, and 1.0 FSE of designed administrative space.

### *SPACE ALLOCATION FOR CAS*

In the 2026-2027 school year, CAS's baseline Footprint allocation will be:

- 9 FS;
- 2 HS; and
- 3.0 FSE for administrative use.
  - CAS's administrative space allocation of 3.0 FSE will be comprised of 2 FS, 1 HS and 2 QS.

### *SPACE ALLOCATION FOR LAFAYETTE ACADEMY*

In the 2026-2027 school year, Lafayette Academy's baseline Footprint allocation will be:

- 13 FS;
- 2 HS; and
- 3.5 FSE for administrative use.
  - Lafayette Academy's administrative space allocation of 3.5 FSE will be comprised of 1 FS, 4 HS, and 2 QS.

### *EXCESS SPACE IN M118 IN THE 2026-2027 SCHOOL YEAR*

Therefore, in the 2026-2027 school year, there will be an excess of 4 FS and 1 QS in M118 after MSC, CAS, and Lafayette Academy have received their baseline or adjusted Footprint allocations.

### **4. Space Allocation in M118 in the 2027-2028 School Year**

If this proposal is approved, beginning in the 2027-2028 school year, MSC will only serve students in grades K-5 and 8 in M118.

### *SPACE ALLOCATION FOR MSC*

In the 2027-2028 school year, MSC's baseline Footprint allocation will be:

- 20 FS;
- 6 HS; and
- 3.5 FSE for administrative use.

The NYCDOE has adjusted MSC's baseline Footprint allocation due to a lack of available HS suitable for instruction in the building. As such, MSC's adjusted baseline Footprint will be:

- 23 FS;
- 3 HS; and
- 3.5 FSE for administrative use.
  - MSC's administrative space allocation of 3.5 FSE will be comprised of 2 FS, 2 QS, and 1.0 FSE of designed administrative space.

### *SPACE ALLOCATION FOR CAS*

In the 2027-2028 school year, CAS's baseline Footprint allocation will be:

- 9 FS;
- 2 HS; and
- 3.0 FSE for administrative use.
  - CAS's administrative space allocation of 3.0 FSE will be comprised of 2 FS, 1 HS and 2 QS.

  - Lafayette Academy's administrative space allocation of 3.5 FSE will be comprised of 1 FS, 4 HS, and 2 QS.

Therefore, in the 2027-2028 school year, there will be an excess of 3 FS and 1 QS in M118 after MSC, CAS, and Lafayette Academy have received their baseline or adjusted Footprint allocations.

### **5. Space Allocation in M118 in the 2028-2029 School Year**

If this proposal is approved, beginning in the 2028-2029 school year, MSC will only serve students in grades K-5 in M118.

In the 2028-2029 school year, MSC's baseline Footprint allocation will be:

- 19 FS;
- 5 HS; and
- 3.0 FSE for administrative use.

The NYCDOE has adjusted MSC's baseline Footprint allocation due to a lack of available HS suitable for instruction in the building. As such, MSC's adjusted baseline Footprint will be:

- 22 FS;
- 2 HS; and
- 3.0 FSE for administrative use.

- MSC’s administrative space allocation of 3.0 FSE will be comprised of 1 FS, 1 HS, 2 QS, and 1.0 FSE of designed administrative space.

### *SPACE ALLOCATION FOR CAS*

In the 2028-2029 school year, CAS’s baseline Footprint allocation will be:

- 9 FS;
- 2 HS; and
- 3.0 FSE for administrative use.
  - CAS’s administrative space allocation of 3.0 FSE will be comprised of 2 FS, 1 HS and 2 QS.

### *SPACE ALLOCATION FOR LAFAYETTE ACADEMY*

In the 2028-2029 school year, Lafayette Academy’s baseline Footprint allocation will be:

- 16 FS;
- 4 HS; and
- 4.0 FSE for administrative use.

The NYCDOE has adjusted Lafayette Academy’s baseline Footprint allocation due to a lack of available HS suitable for instruction in the building. As such, Lafayette Academy’s adjusted baseline Footprint will be:

- 17 FS;
- 3 HS; and
- 4.0 FSE for administrative use.
  - Lafayette Academy’s administrative space allocation of 4.0 FSE will be comprised of 2 FS, 3 HS, and 2 QS.

### *EXCESS SPACE IN M118 IN THE 2028-2029 SCHOOL YEAR*

Therefore, in the 2028-2029 school year, there will be an excess of 3 FS and 1 QS in M118 after MSC and Lafayette Academy have received their baseline or adjusted Footprint allocations.

Therefore, M118 has sufficient space to accommodate MSC, CAS, and Lafayette Academy’s baseline or adjusted baseline Footprint allocations if this proposal is approved. If this proposal is approved, OSM will work with the Building Council to ensure an equitable allocation of the excess space in M118.

### C. Building Safety and Security

MSC, CAS, and Lafayette Academy will update the safety and security plan for M118 prior to the first day of school in the 2026-2027 school year if this proposal is approved. The NYCDOE makes the following safety and security supports available to schools:

- Providing an annual Opening Day resource guide for schools;
- Providing guidance and support to schools with conducting monthly school safety committee meetings where all stakeholders participate to discuss any safety related issues and/or updates. In addition, during these meetings, school occurrence data and crime data is reviewed and monitored in conjunction with New York City Police Department local precinct and School Safety Division representatives;
- Technical assistance in safety and security policies and protocols via the Borough Safety Director;
- Professional development and kits for Building Response Teams; and
- Monitoring and certifying School Safety Plans annually.

### D. Impact on the Community

As mentioned above, since the 2024-2025 school year, the District 3 Superintendent’s team has been convening working group meetings across the district to discuss how we can ensure all of our students have access to these kinds of schools and experiences. The working groups explored ways to support enrollment and school performance and address space challenges at several schools. The working group members include principals, PTA presidents, school and district UFT representatives, and CEC 3 representatives. This proposal was developed through these working group conversations as a solution to address the school’s enrollment challenges in its middle school grades by focusing on a smaller grade span and working to build a quality elementary school option. A gradual truncation, in which the school

stops enrolling students in the entry grade and closes its middle school gradually, also allows current students to remain enrolled at their school as they complete their middle school education.

The NYCDOE is proposing to truncate grades 6-8 of MSC to allow the school to focus on a smaller grade span and continue to build a quality elementary school option. MSC's middle school grades have been experiencing low and declining enrollment. This has created budgetary challenges that have limited the opportunities the school has been able to provide its middle school students. For example, low enrollment in MSC's middle school has meant that its middle school students receive two fewer English Language Arts and math classes per week compared to citywide averages.

Additionally, while the K-8 school model can provide an opportunity for students to benefit from a stable community for a longer period of time, that hasn't been the reality at MSC where most families don't choose to attend the school for both elementary and middle school. From the 2021-2022 school year to the current school year, only between 9 and 14 students have articulated from grade 5 to grade 6 at MSC. If this proposal is approved, this truncation will enable MSC to focus exclusively on serving students in grades K-5 and continue to build a quality elementary school option.

If this proposal is approved by the PEP, beginning in the 2026-2027 school year, MSC will gradually phase out one middle school grade per year until it ultimately serves students in grades K-5 and will be able to focus exclusively on its elementary school grades and further its ability to serve as a quality sustainable elementary school option in District 3. If this proposal is approved, MSC will no longer enroll students in grade 6 after the 2025-2026 school year. In the 2026-2027 school year, MSC will only serve students in grades K-5 and 7-8. In the 2027-2028 school year, MSC will serve students in grades K-5 and 8. After the conclusion of the 2027-2028 school year, MSC will only serve students in grades K-5.

If this proposal is approved, the gradual truncation of MSC's middle school will provide current students in grades 6 and 7, as well as any students in grade 8 who do not meet promotional criteria, with the option to continue their education at MSC alongside their peers through the end of middle school. If this proposal is approved, all current MSC middle school students will continue to be supported in meeting promotional requirements as they continue their education at MSC through eighth grade. If a student does not meet promotional requirements in a grade that will no longer be served by MSC the following year, the District 3 Family Support Coordinator, in collaboration with MSC school staff, will help identify another middle school option for the duration of their middle school experience. Students who receive an offer to MSC for grade 6 will receive individualized support from OSE and the District 3 Superintendent's team to assist with securing seats in other middle schools. Any student who wishes to attend middle school in M118 will have the ability to enroll in Lafayette Academy or CAS if they desire.

As mentioned above, District 3 district schools currently have the capacity to serve approximately 4,450 students in grades 6-8 while only 3,369 such students are currently enrolled in District 3 district schools in the 2025-2026 school year, which means that District 3 currently has an excess of approximately 1,100 grades 6-8 seats in district schools. If the two above-mentioned concurrent proposals impacting buildings M118 and M342 are approved, they will collectively result in the removal of two middle school options in District 3. If both concurrent proposals are approved, District 3 schools will have the capacity to serve approximately 4,100 students in grades 6-8 and will still have an excess of approximately 750 grades 6-8 seats. There are also approximately 689 students in grades 6-8 being served in four charter schools in District 3, which students in District 3 can also apply to.

Therefore, there is a sufficient number of seats within District 3 to accommodate the current students in grades 6-8 of MSC and RSMA.

This proposal is not expected to impact the ability of community members and organizations to obtain school building use permits at M118. This proposal is not expected to impact the building accessibility of M118.

V. Initial Impact on Budget and Costs of Instruction

If this proposal is approved, beginning in the 2026-2027 school year, the NYCDOE will begin to cease to allocate funds to MSC for its middle school grades that will be gradually truncated. Therefore, the approval of this proposal will reduce MSC’s budget and costs of instruction over time, and the NYCDOE will no longer allocate any funds to MSC for any middle school grade in the 2028-2029 school year and beyond. This proposal will not impact costs of instruction for Lafayette Academy or CAS.

Most funding in district schools’ budgets is allocated on a per-pupil basis based on Fair Student Funding (FSF). Under FSF, schools receive money based on the number of students they serve and specific student needs. Specifically:

- The number of students, by grade level;
- The number and needs of students with disabilities;
- The number, needs and programs of ELL students;
- The number of students in temporary housing;
- The number of students with high concentration of need; and
- The number of students with other supplemental academic needs.

For more information about 2025-2026 school year costs of instruction and school funding, please refer to the Fiscal Year 2026 FSF Guide and School Allocation Memoranda. The FY 2026 FSF Guide and School Allocation Memoranda enumerate policies that are specific to the 2025-2026 school year and are subject to change for the 2026-2027 school year.

## VI. Other Impacts

### A. Personnel Needs

This proposal, if approved, is not expected to change the duties or responsibilities of staff assigned to MSC for the remainder of the 2025-2026 school year or of staff assigned to CAS and Lafayette Academy in the current or future school years. This proposal is not expected to impact or change the number of personnel positions assigned to Lafayette Academy and CAS in the current or future school years.

If this proposal is approved, MSC will no longer serve middle school grades over the course of the gradual truncation as the school serves fewer middle school grades and students, and as such some MSC staff may be excessed.<sup>xx</sup> Where possible, the NYCDOE will seek to minimize excessing of represented staff during any approved gradual truncation. All contractual rules regarding excessing will apply.

As MSC is a PROSE school, all contractual agreements with staff/administration will continue to be implemented if this proposal is approved.

Barring system-wide layoffs, excessed teachers will be eligible to apply for other NYCDOE positions, and any staff members who do not find a permanent position will be provided with alternate funded placements in schools in accordance with the collective bargaining agreement (CBA) and other applicable policies.

### B. Administration

This proposal, if approved, is not expected to change the duties or responsibilities of administrators assigned to MSC for the remainder of the 2025-2026 school year or of administrators assigned to CAS and Lafayette Academy in the current or future school years. This proposal is not expected to impact or change the number of administrative personnel positions assigned to Lafayette Academy and CAS in the current or future school years. If this proposal is approved, some MSC administrative positions may be excessed after the 2025-2026 school year since administrative needs may decrease as the school will eventually serve a smaller student population and fewer grades. As noted above, the NYCDOE will work to minimize excessing of represented staff, and any excessing that may be necessary would be conducted in accordance with existing labor agreements and policies.

### C. Transportation

If this proposal is approved, transportation for students at MSC, CAS, and Lafayette Academy will continue to be provided in accordance with Chancellor's Regulation A-801.

The Office of Pupil Transportation will make the final determination as to the mode of transportation to be provided to each student. ## Appendix B: Target Capacity and Utilization

As described in more detail in the 2024-2025 Enrollment, Capacity and Utilization Report, also known as the 2024-2025 Blue Book, a building's target utilization rate is calculated by dividing the aggregated enrollment of all the school organizations in the building by the aggregated target capacities of those organizations. Each school organization's target capacity is calculated based upon the following components:

- The scheduled use of individual rooms as reported by principals during an annual facilities survey; and
- The NYCDOE's goals for maximum classroom capacities, which are lower than the United Federation of Teachers contractual class sizes and differ depending on grade level.

The most recent year for which target capacity has been calculated for buildings is 2024-2025. The NYCDOE's projected utilization rates for the 2025-2026 school year and beyond are based on those figures. Thus, projected utilization rates for 2025-2026 and beyond provide only an approximation of a building's usage because each of the factors underlying target capacity may be adjusted by a principal from year to year to better accommodate students' needs.

For example, changing the use of a room from an administrative room to a homeroom at the high school level will increase a building's overall target capacity because for high schools, administrative rooms are not assigned a capacity. Holding enrollment constant, this change will result in a lower utilization rate. Similarly, if a room previously used as a kindergarten classroom is subsequently used as a fifth-grade classroom, the building's target capacity will increase because it is anticipated that a fifth-grade class will have more students than a kindergarten class. This is reflected in the fact that the NYCDOE's goal for maximum classroom capacity is higher for fifth-grade classrooms than for kindergarten classrooms. In this example, as well, assuming enrollment is constant, the utilization rate will decrease.

## Appendix C: Instructional Footprint

The Footprint sets forth the baseline number of rooms that should be allocated to a school based on the grade levels it serves and number of classes per grade it offers. For existing schools, the Footprint is applied to the current number of classes and class size a school is programming. It is confirmed by a walkthrough of the building conducted by a representative from the Office of Space Management and a school representative.

For elementary schools serving students in grades K-5 and for all 3-K and pre-K programs, the Footprint assumes that classes are self-contained. Therefore, the Footprint allocates one full-size room for each general education or Integrated Co-Teaching section and a full-size or half-size room to accommodate each Special Class section served by the school. In addition to these rooms, schools serving grades K-5 receive an allocation of cluster or specialty rooms proportionate to the number of students enrolled. These spaces can be used at the principal's discretion for purposes such as art or music instruction.

For grades 6-12, the Footprint assumes that students move from class to class and that classrooms should be programmed at maximum efficiency. The Footprint does not require that every teacher have his or her own designated classroom. Principals are asked to program their schools efficiently so that classrooms can be used for multiple purposes throughout the course of the school day.

The Footprint allocates the number of baseline classrooms for student support services, resource rooms, and administrative space based on the grades a school serves and its enrollment at scale.
